as per Italian Law (DPR N° 642 of 26 October 1972 – Engl. "A" and subsequent modifications)

Bills issued in Italy and payable abroad	9‰ of face amount
Bills issued abroad and payable in Italy of payable abroad	12‰ of face amount

(50% reduction if bills bear stamp duty of the respective Country of origin)
